In addition to being contracted and fully certified, each agent must be appointed, at his/her expense, with the Universal American company(ies) offering the Medicare Advantage 2010 plans he/she is selling. Appointment must be made through the insurance department of the state(s) in which the agent is licensed and selling Universal American Medicare Advantage plans.
